GENERAL INFORMATION & BYLAWS **FOR** **CCA SIX-A-SIDE TOURNAMENT-2010**

1) **GENERAL**

The normal laws of cricket shall apply to the entire Tournament unless otherwise stipulated.

2) **TOSS**

The Captain will toss for the innings 15 minutes before the match is scheduled to commence.

3) **UNIFORM**

All players to participate in proper white cricket uniform.

4) **REGISTRATION**

A list with full names of registered players must be submitted to the undersigned before the start of the Tournament. Each team is allowed to register a maximum of EIGHT players with only SIX taking part. A player shall play for only ONE team during the TOURNAMENT.

5) **DURATION OF MATCH**

- a. Each match will consist of 10, six ball overs, each being limited to 5 overs.
- b. No bowler will bowl more than ONE over.
- c. Each side must bat for full 5 overs, unless bowled out during lesser number of overs.
- d. The format of the tournament shall be as per the organizers decision and shall be interceded at the time of the draw.

6) **SCORING**

- a. After scoring 15 runs, the batsman automatically retires. Additional runs scored by a single stroke when passing the fifteen runs mark shall be included in the teams aggregate score.

7) **RESULTS**

- a. The team that scores more runs than the other team in a particular match is the winner.

- b. In case of a tie, the team that will have lost the least number of wickets shall be the winner. In case of a further tie, a replay consisting of two overs each / bowl out, would be played to determine the winner. (At the discretion of the organizing committee)
- c. The entire team is automatically out after losing 5 wickets.

8) DRAW

The draw shall take place a day before the tournament start.

9) UMPIRES DECISION

Umpires decision shall be final and binding. Umpires shall be appointed by the organizing Committee.

10) PROTESTS

Protests, if any, should be lodged in with the undersigned soon after the game in dispute.

The decision of the organizing committee shall be final and binding pertaining to the Tournament.
